I specifically agree to assume all risk, responsibility and liability for any and all loss, injury and/or damage suffered by me, and/or my family's participation in any trip, party, social function, and/or any other activity promoted and/or sponsored by the Club, including, without limitations, injuries, damage, and/or loss of property caused by the negligence or failure to act of the officers, directors, employees, agents, and/or representatives of the Club. I agree to release and indemnify and hold harmless CFSS and its reps (trip/activity leaders, board members, and officers) for any loss, injury or damage resulting directly or indirectly from any trip or activity sponsored by CFSS. I agree that I am solely responsible for my safety and conduct and meeting all payment deadlines. Should I miss departure, I understand that I will not be able to recover any part of the trip or activity payment. I agree to abide by the By-laws, rules and regulations of the club. CFSS is acting only as a trip coordinator and is not a travel agent nor is it representing itself as one. CFSS accepts no responsibility for the services of airlines, bus, lodging or other tour or travel services being offered such as delayed departures, cancelled or changed flights, lodging substitutions, bus breakdowns or bus failure of any nature. CFSS accepts no responsibility for weather ( lack of snow conditions or number of ski lifts open ).

**Trip Cancellation / Substitution Policy**

Cancellation of a trip, or substituting someone else in your place, will result in a penalty fee for each trip participant who cancels or is substituted. The penalty shall be a minimum of \$75 plus any other costs incurred by CFSS. All cancellations shall be made by written notification or e-mail to the Trip Leader. In the event that a trip is cancelled by CFSS for lack of snow, or any other reason beyond the control of CFSS, trip participants may be subject to a prorated sharing of Club costs incurred in the cancellation.
